**SUPERINTENDENT'S INFORMATION REPORT**

Prior to the meeting the school board members and public witnessed a presentation by the middle school and 6<sup>th</sup> grade archery teams.

Mr. Zeigafuse thanked the school board and Ms. Poliskiewicz for the ability to form the archery club. Mr. Zeigafuse stated the middle school archery club had approximately 40 to 50 members and 36 members were taken to the state competition where Cheyenne Dailey placed third in the 7<sup>th</sup> grade girls division.

Mr. Mort stated the 6<sup>th</sup> grade archery club had 120 members. Mr. Mort stated the team that competed in the state tournament placed third. Mr. Mort stated Erin Snyder placed third and Mikayla Mulea placed second in the individual competition. Mr. Mort stated the school hopes to open the club to 5<sup>th</sup> and 6<sup>th</sup> graders next year.

Mr. Zeigafuse stated the club won a bow that will be raffled off and the proceeds will be used to purchase additional equipment.

Mr. Pruett asked Mr. Reinhart if the administration has plans for expending these funds.

Mr. Reinhart stated not at this time because the district has not received any direction from the state on the guidelines to spending the funds.
